May kindly see the property statement submitted online dated 10.12.2019 received from Sri Subhash Chandra-VIII, Additional Principal Judge, Family Court, Saharanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, total income is Rs.30,55,926/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, Home Loan, LIC policies and PPF a/cs are Rs.18,86,719/-. Thus, a sum of Rs.11,69,207/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.6,11,830/- this financial year from previous year's balance.

In this connection, it is submitted that hat the officer has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice B.Amit Sthalekar, the then Administrative Judge, Balrampur in the misc. file of the officer. And of the financial years 2010-11 & 2011-12, 2012-13 & 2013-14 and 2014-15 & 2015-16 are currently processed & separate notes has made on case-id no.441,452 and 454 respectively..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 10.12.2019. As such, there is delay in submitting the same from the part of the officer for which he has extremely apologetic for the delay in submitting the property statement and submitting the same for perusal, for which he shall be highly obliged.
