May kindly see the property statement submitted online dated 11.12.2019 received from Sri Mohammad Firoz, Secretary, DLSA, Jaunpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19, income from salary is Rs.16,64,546/- and total deductions/ repayment/ savings/ investment against GIS, CPF, Income Tax, LIC, PPF, FD are Rs.2,60,407/-. Thus, a sum of Rs.14,04,139/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year. And the balance of his savings bank account(s) is also reduced for Rs.85,146/- this financial year from previous year's balance.

In this connection, it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2014-15 which has already been seen by Hon'ble Mrs. Justice Sunita Agarwal, the then Administrative Judge, Hathras in the misc. file of the officer with the warning issued to the officer shall be remain careful/ prompt in submission of his property statement and of the financial year 2015-16, 2016-17 & 2017-18, which are currently processed on case-id no.471, 472 & 473 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements

for the financial year 2018-19 vide online dated 11.12.2019. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 of Sri Mohammad Firoz, Secretary, DLSA, Jaunpur be laid before Hon'ble Mr. Justice Abhinava Upadhya, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
