May kindly see the online letter 28.12.2019 received from Sri Anil Kumar - VI, Addl. District and Sessions Judge, Hardoi regarding submission of statements of movable and immovable properties for the financial years 2016-17 and 2017-18 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

- 1. In the financial year 2016-17, his gross income from salary and other sources is Rs. 12,44,348/- (Rs. 11,85,554/-from salary and Rs. 58,794/- from Transfer T.A.) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, and LIC is Rs.4,30,009/-. Thus a sum of Rs. 8,14,339/-was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17. The balance of Rs. 29,965/- has decreased from his saving bank A/c against the balance of the previous year.
  - 1. In the financial year 2017-18, his gross income from salary and other sources is Rs.15,69,527/- (Rs.12,74,297/-from salary and Rs. 2,95,230/- from NSC maturity) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Loan-repayment and LIC is Rs.6,29,973/- (including enhancement of balance of Rs. 64,858/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 9,39,554/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.

In this connection it is submitted that Sri Anil has already submitted his property statements upto the financial year 2015-16 which has already been seen by Hon'ble Mr. Justice Suneet Kumar, the then Administrative Judge, Moradabad in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 have been submitted by the Officer vide his online case id no. 494 dated 28.12.2019 which was due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2016-17 and 2017-18 of Sri Anil Kumar -VI, Addl. District and Sessions Judge, Hardoi be laid before Hon'ble Mr. Justice Ritu Raj Awasthi,
