May kindly see the property statement submitted online dated 07.10.2020 received from Sri Rajnesh Kumar, Additional District Judge, Jaunpur regarding submission of statement of movable and land held/ immovable properties acquired/held by him or any member of his family of the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and land held/ immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, Total income is Rs.38,35,815/- (income from salary is Rs.37,89,815/-, allowances of Rs.31,000/- and income from Agriculture is Rs.15,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, PPF, PLI, Tuition Fees, CPF, Income Tax and Kerala Relief Fund are Rs.14,65,704/-. Thus, a sum of Rs.23,70,111/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.54,064/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2014-15 which had already been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Saharanpur in the misc. file of the officer and of the financial years 2015-16 & 2016-17, a separate note has been made on case-id no.495.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has attached movable and landheld/immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online

dated <u>01.01.2020</u> and filled only the details of 2018-19 in the bock proforma of 2017-19 (officer has asked to fill the details of both the financial years in the block proforma of 2017-19 vide Court's objection dated 31.01.2020, 18.02.2020 & 05.10.2020 but everytime he attached instead of filling the details for the view at a glance). As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 of Sri Rajnesh Kumar, Additional District Judge, Jaunpur be laid before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
