May kindly see the property statements submitted online dated 02.01.2020 received from Sri Pradeep Kumar Singh-II, Special Judge (SC/ST, Pev. Of Atroci act), Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2016-17 & 2017-18, income from salary is Rs.35,68,920/- (including Petrol Allowance, Newspaper Allowance, Drawing Allowance, Dress Allowance, Administration Work Allowance and Training Traveling & Dearness Allowance, E. L. Encashment, interest from different investments) and total deductions/ repayment/ savings/ investments against GIS, CPF, Income Tax, Car loan, ICICI pru. Policy, Child Care policy, D-mat a/c, PPF, NSC, FD in both the financial years and the balance of his savings bank account(s) is enhanced for Rs.52,572/- this financial year from previous year's balance, total of which is Rs.18,00,423/-. Thus, a sum of Rs.17,68,497/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

In this connection, it is submitted that Sri Pradeep Kumar Singh-II has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Shri Narayan Shukla, the then Administrative Judge, Lucknow in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements

for the financial years 2016-17 & 2017-18 vide online dated 02.01.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to immense indulgence in the official duties as Additional Director (Admin) at JTRI U.P., Lucknow during the period from 1<sup>st</sup> April 2016 to April 2018, the property statement could not be submitted earlier within due time inadvertently and beg his pardon for the same in his reply/letter dated 16.01.2020.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Pradeep Kumar Singh-II, Special Judge (SC/ST, Pev. Of Atroci act), Varanasi be laid before Hon'ble Mr. Justice Abinava Upadhya, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
