May kindly see the property statement submitted online dated 03.01.2020 received from Sri Rajesh Kumar Mishra, Additional District & Sessions Judge (F.T.C.), Lakhimpur Kheri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties of the financial years 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19, income from salary is Rs.13,98,686/- and total deductions/ repayment/ savings/ investment against GIS, GPF, LIC policies, Income Tax with cess, Home loan, Personal loan, Tution fees and the balance of his savings bank account(s) is enhanced for Rs.49,505/- this financial year from previous year's balance, total of which is Rs.7,32,782/-. Thus, a sum of Rs.6,65,904/- was therefore available with him to meet out the household expenditure of his family consisting four members in whole of the financial year.

In this connection, it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2016-17 which has already been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Agra in the misc. file of the officer and of the financial year 2017-18, which are currently processed on case-id no.490.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2018-19 vide online dated 03.01.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 of Sri Rajesh Kumar Mishra, Additional District & Sessions Judge (F.T.C.), Lakhimpur Kheri be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Kheri Judgeship for His Lordship's kind perusal and orders?
