May kindly see the online letter 15.09.2019 received from Sri Deepak Kumar Mishra, Addl. Civil Judge (Sr. Div.), Aligarh regarding submission of statements of movable and immovable properties for the financial year 2018-19 proforma to this Court for kind perusal and information as required by the Court.

Earlier the officer had submitted his movable and immovable property statement for the financial year 2018-19 but he had not shown amount deposited against PPF, SIP and Mutual Fund in the financial year 2018-19. So an objection was raised on 15.11.2019 to mention the aforesaid amount. In reply to this objection the officer has submitted his revised movable and immovable property statements as **an attachment** on 29.11.2019. In the aforesaid property statements, it was found that no money was left with him in the financial year 2018-19 to maintain the household expenditure of his family. So an objection was raised dated 17.12.2019 to ask the officer to clarify how he had managed to maintain his family expenditure in the financial years 2018-19.

In reply to the objection dated 17.12.2019, the officer has submitted his clarification dated 04.03.2019 about how he had managed to maintain his family expenditure in the financial years 2018-19 is reproduced in verbatim:

Note.:- I have only one son aged almost two years and a wife. Thus there are only three family members/dependents.

Note:- In the FY 2018-19 wife was living in her parental home for competitive examination purposes and my mother was living with me. At that time father was posted at Firozabad/Bulandshahar as Chairman Consumer Form after retirement from UP Judicial Services. Father used to come frequently to live with me. Father use to bear expenses of my mother and mine. He has withdrawn almost Rs. 7,05,000/- for said purposes and other expenses in FY 2018-19.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2018-19, his gross income from salary and other sources is Rs.14,56,665/- (Rs. 14,31,312/- from salary and Rs. 25,353/- from S.B. interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, SIP and Mutual Fund is Rs.12,46,456/- (including enhancement of balance of Rs. 44,449/- in his saving bank A/cs against the balance of the previous year). Thus a sum of Rs. 2,10,209/- was therefore

available with him to meet out the household expenditure of his family consisting of three members in the financial year 2018-19.

In this connection it is submitted that the Officer has already submitted his property statements upto the financial year 2016-17 which has already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Allahabad in the miscellaneous file of the Officer.

For the preceding financial year, the officer has submitted his property statements for the financial year 2017-18 which has been processed presently online and separate office note has already been submitted for orders on separate case id no. 33

The movable and immovable property statement for the financial year 2018-19 have been submitted by the Officer vide his online case id no. 50 dated 15.09.2019 which is due to be submitted upto the end of the financial year 2019-20. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial year 2018-19 of Sri Deepak Kumar Mishra, Addl. Civil Judge (Sr. Div.), Aligarh be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
