May kindly see the online letter 08.01.2020 received from Smt. Reema Malhotra, Addl. District and Sessions Judge/FTC, Etah regarding submission of statements of movable and immovable properties for the financial years 2009-10 and 2010-11 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2009-10 and 2010-11 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

- 1. In the financial year 2009-10, her gross income from salary and other sources is Rs. 2,10,902/- (Rs. 2,09,604/- from salary and Rs. 1,298/- from S.B. A/c interest) and total deductions/Savings/investments against GIS, PPF, and LIC is Rs.1,38,483/- (including enhancement of balance of Rs. 1,06,649/- in her saving bank a/c against the balance of the previous year). Thus a sum of Rs. 72,419/- was therefore available with her to meet out the household expenditure of her family consisting of one member in the financial year 2009-10.
- 2. In the financial year 2010-11, her gross income from salary and other sources is Rs.3,89,860/- (Rs.3,84,553/-from salary and Rs. 5,307/-from S.B. A/c interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Loan-repayment and LIC is Rs.2,49,063/- (including enhancement of balance of Rs. 15,253/- in her saving bank A/c against the balance of the previous year). Thus a sum of Rs. 1,40,797/- was therefore available with her to meet out the household expenditure of her family consisting of two members in the financial year 2010-11.

In this connection it is submitted that Smt. Malhotra has already submitted her property statements held at the time of entering Judicial Services which has already been seen by Hon'ble Mr. Justice Surendra Singh, the then Administrative Judge, Farrukhabad in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial years 2009-10 and 2010-11 have been submitted by the Officer vide her online case id no. 526 dated 08.01.2020 which was due to be submitted upto the end of the financial year 2011-12. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2009-10 and 2010-11 of Smt. Reema Malhotra, Addl. District and Sessions Judge/FTC, Etah be laid before Hon'ble Mr. Justice B. Amit
