May kindly see the online letter 08.01.2020 received from Smt. Reema Malhotra, Addl. District and Sessions Judge/FTC, Etah regarding submission of statements of movable and immovable properties for the financial years 2015-16 and 2016-17 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-16 and 2016-17 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial year 2015-16, her gross income from salary and other sources is Rs. 9,99,980/- (Rs. 9,08,129/- from salary and Rs. 91,851/- from S.B. A/c interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF and LIC is Rs. 8,09,564/- (including enhancement of balance of Rs. 5,31,345/- in her saving bank a/c against the balance of the previous year). Thus a sum of Rs. 1,90,416/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2015-16.
2. In the financial year 2016-17, her gross income from salary and other sources is Rs. 12,31,455/- (Rs.10,87,035/- from salary and Rs. 1,44,420/- from S.B. A/c interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF and LIC is Rs. 9,00,916/- (including enhancement of balance of Rs. 4,34,267/- in her saving bank A/c against the balance of the previous year). Thus a sum of Rs. 3,30,539/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2016-17.

It is pertinent to mention that husband of the officer, Sri Ritesh Sachdeva is Class-1, Gazetted Officer whose annual income are Rs. 8.90 lacs in 2015-16 and Rs. 11 Lacs in 2016-17.

In this connection it is submitted that Smt. Malhotra has already submitted her property statements held at the time of entering Judicial Services which has already been seen by Hon'ble Mr. Justice Surendra Singh, the then Administrative Judge, Farrukhabad in the miscellaneous file of the Officer. For the preceding financial years, she has submitted her property statements for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 which have been processed presently online and separate office notes have already been submitted for orders on separate case id nos. 526 and 527 but in the property statements for the financial years 2013-14 and 2014-15, an

objection has been raised to clarify the enhancement of salary for the financial year 2014-15 against the the salary of the financial year 2013-14 on case id no 529.

The movable and immovable property statement for the financial years 2015-16 and 2016-17 have been submitted by the Officer vide her online case id no. 530 dated 08.01.2020 which was due to be submitted upto the end of the financial year 2017-18. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2015-16 and 2016-17 of Smt. Reema Malhotra, Addl. District and Sessions Judge/FTC, Etah be laid before Hon'ble Mr. Justice B. Amit Sthalekar, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
