## Registrar (J)(Budget)

May kindly see the online 15.01.2020 received from Sri Mohd Sajid, Civil Judge (Jr. Div.), Barabanki regarding submission of statements of movable and immovable properties for the financial years 2016-17 and 2017-18 on proforma to this Court for kind perusal and information as required by the Court.

In the aforesaid property statements, it was found that Rs. 8,698/- and Rs. 87,774/- were left with him in the financial years 2016-17 and 2017-18 respectively. So an objection was raised dated 18.02.2020 to ask the officer to clarify how he had managed to maintain expenditure of his family in the financial years 2016-17 and 2017-18. In reply to this objection, the officer has submitted his clarification on dated 27.02.2020. The clarification submitted by the officer is being reproduced in verbatim:-

""I most humbly submits that there are six members (father, mother, wife, a son and a daughter.) in my family. My father Sri Mohd Najim Ali is a retired U.P. Government class IV employee (worked as Line-Man in Municipality, Muzaffarnagar) and he is getting pension after the retirement in 2016. My parent do not live with me. They live in my native place (Village- Shernagar, Muzaffarnagar). My father has sufficient income from pension for the household expenses of himself and my mother. Thus my father and mother are not dependant on me.

My wife (Smt.Rukashna) has been a working woman and has been running a trading business (Firm's Name- Universal Traders dealing in items- Glass, Aluminium products, Glass Hardware, based in Lucknow ). My son (Mohd Suhail, who is persuing 5 years BA.LL.B course and he is 21 years old approx) also assists his mother in the business. ITR of my wife for the last three financial years are being mentioned as under:

FY2016-17- Rs.60,000/- ( from Jan,2017 to March, 2017) ; FY2017-18-Rs.2,58,380/-; FY2018-19- Rs. 1,95,000/.

I further most humbly submit that we both (myself and my wife) together bear the household expenses. Wherever I was not regular in withdrawals from the salary account, my wife was meeting out the household expenses. The withdrawals

FY2016-17- Rs.2,76,822/-; FY2017-18- Rs.4,26,082/-; FY2018-19- Rs. 5,57,103/-.

The drawings from the business of the firm of my wife for the last three financial years are being mentioned as under:

from her business in the last three financial years have been mentioned above in the form of drawings. Thus this is the reason of less withdrawals from my salary bank account of SBI.""

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

- 1. In the financial year 2016-17 (13.01.2017 to 31.03.2017), his gross income from salary is Rs. 1,08,957/- and total deductions/Savings/investments against GIS is Rs. 1,00,259/- (enhancement of balance of Rs. 99,859/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 8,698/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17 (13.01.2017 to 31.03.2017).
- 2. In the financial year 2017-18, his gross income from salary is Rs. 8,40,454/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF and insurances is Rs. 7,52,680/- ( including enhancement of balance of Rs. 4,96,797/- in his saving bank A.c against the balance of the previous year). Thus a sum of Rs. 87,774/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.

For the preceding financial year, the officer has submitted his property statements held at the time of entering Judicial Services which has been processed presently online and separate office note has already been submitted for orders on separate case id no. 596.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 have been submitted by the Officer vide his online case id no. 598 dated 15.01.2020 which was due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer and he has apologized for the delay caused. May, if approved, the movable and immovable property statements for the financial years 2016-17 and 2017-18 of Sri Mohd Sajid, Civil Judge (Jr. Div.), Barabanki be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
