May kindly see the online 15.01.2020 received from Sri Om Pal Singh, Civil Judge (Sr. Div.), Gautam Buddha Nagar regarding submission of statements of movable and immovable properties for the financial years 2017-18 and 2018-19 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 and 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial years 2017-18, his gross income from salary is Rs. 10,36,539 and total deductions/Savings/investments against NPS, GIS, income tax and LIC is Rs. 3,01,540/- (including enhancement of balance of Rs.90,568/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs.7,34,999/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.
2. In the financial years 2018-19, his gross income from salary and other sources is Rs. 19,26,003/- (Rs. 15,66,003/- from salary and Rs. 3,60,000/- from father as family assets distribution and total deductions/Savings/investments against NPS, GIS, income tax and LIC is Rs. 14,29,023/- (including enhancement of balance of Rs.9,87,002/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 4,96,980/ was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19.

It is pertinent to mention that Smt. Rashmi Singh, the wife of the officer, is a TGT (English) in KVS, Hapur whose monthly income is Rs. 75,000/-

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2016-17 which has already been seen by Hon'ble Mr. Justice P.K.S. Baghel, the then Administrative Judge, Gautam Budha Nagar in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2017-18 and 2018-19 have been submitted by the Officer vide his online application dated 15.01.2020 which were due to be submitted upto the end of the financial year 2019-20. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the statements of movable and immovable property for the financial years 2017-18 and 2018-19 of Sri Om Pal Singh, Civil Judge (Sr.
