May kindly see the property statement submitted online dated 23.01.2020 received from Smt. Jyotsna Sharma, District & Sessions Judge, Kasganj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2016-17 & 2017-18, income from salary is Rs.25,74,082/-and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, PPF a/cs and the balance of her savings bank account(s) is enhanced for Rs.5,85,826/- this financial year from previous year's balance, total of which is Rs.23,78,755/-. Thus, a sum of Rs.1,95,327/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is Additional District Judge having annual income of Rs.13,60,000/- & Rs.14,55,000/- in the financial year 2016-17 & 2017-18 respectively.

In this connection, it is submitted that from the perusal of the misc. file of the officer, Smt. Jyotsna Sharma has already submitted her property statement upto the financial year 2011-12 which had already been seen by Hon'ble Mr. Justice Ashwani Kumar Singh, the then Administrative Judge, Firozabad. And property statements of the financial years 2012-13 to 2015-16 has been submitted before Hon'ble Ritu Raj Awasthi, Administrative Judge, Lucknow for kind perusal and orders on the detailed office note.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 23.01.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 of Smt. Jyotsna Sharma, District & Sessions Judge, Kasganj be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Kasganj Judgeship for His Lordship's kind perusal and orders?
