May kindly see the property statement submitted online dated 23.01.2020 received from Sri Manas Vatsa, Civil Judge (Jr. Div.), Shahjahanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 (i.e., from 08.02.2017 to 31.03.2018) & 2018-19, income from salary is Rs.18,66,353/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, Income Tax, PPF, FD, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.1,62,490/- this financial year from previous year's balance, total of which is Rs.5,70,330/-. Thus, a sum of Rs.12,96,023/- was therefore available with him to meet out the household expenditure of his family consisting three members for both the financial years.

It is petinent to mention here that his wife's gross income of Rs.6,61,422/- and Rs.2,89,880/- in the financial years 2017-18 & 2018-19 respectively from business.

In this connection, it is submitted that Sri Manas Vatsa has already submitted his property statement at the time of entering into judicial service which had already been submitted online before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Shahjahanpur on case-id no.629.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated

23.01.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Manas Vatsa, Civil Judge (Jr. Div.), Shahjahanpur be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Shahjahanpur Judgeship for His Lordship's kind perusal and orders?
