May kindly see the online 24.01.2020 received from Sri Mahesha Nand Jha, Addl. District and Sessions Judge, Aligarh regarding submission of statements of movable and immovable properties for the financial years 2010-11 and 2011-12 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2010-11 and 2011-12 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2010-11, his gross income from salary and other sources is Rs. 9,35,876/- (Rs. 5,70,114/- from salary and Rs. 3,65,762/- from Arrear) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Insurance, NSC and Bond is Rs. 6,78,596/- (including enhancement of balance of Rs. 1,36,291/- in his saving bank A.cs against the balance of the previous year). Thus a sum of Rs.2,57,280/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2010-11.
2. In the financial year 2011-12, his gross income from salary is Rs. 8,69,196/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, FD, Insurance, NSC and Bond is Rs.4,16,033/-. Thus a sum of Rs. 4,53,163/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2011-12. The balance of Rs. 51,788/- has decreased from his saving bank A/cs against the balance of the previous year.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2009-10 which has already been seen by Hon'ble Mr. Justice V. K. Mathur, the then Administrative Judge, Kushinagar in the in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2010-11 and 2011-12 have been submitted by the Officer vide his online application dated 24.01.2020 which was due to be submitted upto the end of the financial year 2012-13. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2010-11 and 2011-12 of Sri Mahesha Nand Jha, Addl. District

and Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
