May kindly see the online 24.01.2020 received from Sri Mahesha Nand Jha, Addl. District and Sessions Judge, Aligarh regarding submission of statements of movable and immovable properties for the financial years 2014-15 and 2015-16 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-15 and 2015-16 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2014-15, his gross income from salary is Rs. 9,53,770/- and total deductions/Savings/investments against GIS, Income Tax, PPF and Insurance is Rs. 3,49,668/- (including enhancement of balance of Rs.34,878/- in his saving bank A.cs against the balance of the previous year). Thus a sum of Rs.6,04,102/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.
2. In the financial year 2015-16, his gross income from salary is Rs. 12,18,757/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF and Insurance is Rs.9,24,471/- (including enhancement of balance of Rs.2,43,237/- in his saving bank A.cs against the balance of the previous year).. Thus a sum of Rs. 2,94,286/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16. The balance of Rs.59,675/- has decreased from his saving bank A/cs against the balance of the previous year.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2009-10 which has already been seen by Hon'ble Mr. Justice V. K. Mathur, the then Administrative Judge, Kushinagar in the in the Misc. file of the officer.

For the preceding financial years, the officer has submitted his property statements for the F.Y. 2010-11, 2011-12, 2012-13 and 2013-14 which have been processed presently online and separate office notes have already been submitted for orders on separate case id no.632 and 638.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 have been submitted by the Officer vide his online application dated 26.01.2020 which was due to be submitted upto the end of the financial year 2016-17. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2014-15 and 2015-16 of Sri Mahesha Nand Jha, Addl. District and Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
