May kindly see the property statement submitted online dated 26.01.2020 received from Sri Sushil Kumar-IV, Additional District & Sessions Judge/F.T.C., Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, income from salary is Rs.24,29,773/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Insurance policies, PPF a/c, CPF, Income Tax, Sukanya Samriddhi Yojna, Car Ioan and Personal Ioan are Rs.11,71,073/-. Thus, a sum of Rs.12,58,700/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.15,846/- this financial year from previous year's balance.

In this connection, it is submitted that Sri Sushil Kumar-IV has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice S.S.Chauhan, the then Administrative Judge, Bareilly in the misc. file of the officer and of the financial year 2014-15 & 2015-16, which is currently processed on case-id no.640.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-17 & 2017-18 vide online dated 26.01.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Sushil Kumar-IV, Additional District & Sessions Judge/F.T.C., Jhansi be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders?
