May kindly see the online application dated 23.10.2020 received from Sri Mahesha Nand Jha, Addl. District and Sessions Judge, Aligarh regarding submission of statements of movable and immovable properties for the financial years 2016-17 and 2017-18 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

- 1. In the financial year 2016-17, his gross income from salary is Rs.12,70,088/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Insurance and the balance of his saving bank A/C is enhanced for Rs.5,33,282/- from the balance of the previous year, total of which is Rs.12,32,832/-. Thus a sum of Rs.37,256/- was therefore available with him to meet out the household expenditure of his family consisting four members in whole of the financial year. Besides this, officer has also received Rs.2,31,000/- return from Yamuna Express way and matured amount of NSC is Rs.40,025/- in this financial year.
- 2. In the financial year 2017-18, Total income is Rs.16,02,032/- (income from salary is Rs.12,34,540/- and matured amount of NSC is Rs.3,67,492/-) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Insurance and the balance of his saving bank A/C is enhanced for Rs.7,95,673/- from the balance of the previous year, total of which is Rs.15,22,260/-. Thus a sum of Rs.79,772/- was therefore available with him to meet out the household expenditure of his family consisting four members in whole of the financial year.

It is pertinent to mention here that the applicant brings rice, wheat, pulses, oil etc. from his house which is grown in common agricultural field.

In this connection it is submitted that the officer has already submitted his property statements up to the financial year 2009-10 which has already been seen by Hon'ble Mr. Justice V. K. Mathur, the then Administrative Judge, Kushinagar in the in the Misc. file of the officer. For the preceding financial years, the officer has submitted his property statements for the F.Y. 2010-11 & 2011-12, 2012-13 & 2013-14 and 2014-15 & 2015-16 which have been processed presently online and separate office notes have already been submitted for orders on separate case id no.632, 638 and 639 respectively.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 have been submitted by the Officer firstly vide his online application dated 04.02.2020 which was due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer of which no explanation is submitted by him.
