May kindly see the online letter 18.09.2019 received from Sri Neeraj Nigam, District and Sessions Judge, Faizabad regarding submission of statements of movable and immovable properties for the financial years 2016-17 prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2016-17, his gross income from salary is Rs.16,49,083/-and total deductions /Savings/investments against GPF, GIS, Income Tax, PPF, insurances and loan-repayment is Rs.8,20,733/- (including enhancement of Rs. 30,306/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs.8,28,350/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17.

In this connection it is submitted that Sri Nigam has already submitted his property statements upto the financial years 2012-13 and 2013-14 which have already been seen by Hon'ble Mr. Justice A.P. Sahi, the then Administrative Judge, Agra in the miscellaneous file of the Officer. For the preceding financial years, he has submitted his property statements upto the financial years 2014-15 and 2015-16, which has been processed presently online and separate office note has already been submitted for order on separate **case id no. 62 and 63** respectively.

The movable and immovable property statements for the financial year 2016-17 has been submitted by the Officer vide his online letter dated 18.09.2019 which was due to be submitted upto the end of the financial year 2018-19 as per two year block policy. As such, there is delay in submitting the property statements from the part of the officer for which he has stated that due to mistake, he could not submit the statement and regretted for the delay caused.

May, if approved, the movable and immovable property statements for the financial year 2016-17 of Sri Neeraj Nigam, District and Sessions Judge, Faizabad be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders?
