May kindly see the property statement submitted online dated 05.03.2020 received from Sri Avanish Kumar Rai, Additional District Judge/F.T.C., Mahoba regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2015-16 & 2016-17, income from salary is Rs.21,22,950/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, LIC policies, PPF a/c, Home Ioan and the balance of his savings bank account(s) is enhanced for Rs.5,96,423/- this financial year from previous year's balance, total of which is Rs.11,00,624/-. Thus, a sum of Rs.10,22,326/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife earns annual income of Rs.50,000-1,00,000/- from Legal profession.

In this connection, it is submitted that Sri Avanish Kumar Rai has already submitted his property statement upto the financial years 2014-15 which had already been seen by Hon'ble Mr. Justice Suneet Kumar, the then Administrative Judge, Moradabad in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 vide online dated 07.02.2020. As such, there is delay in submitting the same from the

part of the officer for which he has stated that due to some personal reason he was not able to send the property statement on time for which he seek deep apology from the Hon'ble Court and in future such mistake would not be repeated in his reply dated 27.02.2020.

May, therefore, if approved, property statements of the financial years 2015-16 & 2016-17 of Sri Avanish Kumar Rai, Additional District Judge/F.T.C., Mahoba be laid before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Mahoba Judgeship for Her Lordship's kind perusal and orders?
