May kindly see the property statement submitted online dated 15.09.2020 received from Sri Aditya Chaturvedi, Additional District & Sessions Judge, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, Total income is Rs.32,87,896/- [income from salary is Rs.24,98,198/- and other allowances, reimbursements etc. (leave salary, D.A. Arrear, leave encashment, T.A., HRA arrear, dividend, SB & PPF interest, LTC reimbursement etc.) of Rs.7,89,698/-] and total deductions/repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, NPS, PPF, mutual funds, Insurance policies, SIP, FD, purchase of Car & gold ornaments and the balance of his savings bank account(s) is enhanced for Rs.2,58,763/- this financial year from previous year's balance, total of which is Rs.29,06,406/-. Thus, a sum of Rs.4,78,807/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years 2016-17 & 2017-18.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Lucknow with the order issued to the officer concerned shall submit his movable & immovable property statements well within time in future (in the misc. file of the officer).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March

2019. He has submitted movable and immovable property statements of the financial years 2016-17 [firstly vide offline letter dated 18.10.2017 (with 2015-16) in the misc. file] & 2017-18 firstly vide online dated 05.02.2020 (with 2018-19). As such, there is delay in submitting the property statement of the financial year 2017-18 (which has happened due to the confusion of officer in block period). May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Sri Aditya Chaturvedi, Additional District & Sessions Judge, Lucknow be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
