May kindly see the online letter 07.02.2020 received from Sri Ravi Kant, Addl. District and Sessions Judge, Budaun regarding submission of statements of movable and immovable properties for the financial years 2016-17 and 2017-18 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

- 1. In the financial year 2016-17, his gross income from salary and other sources is Rs. 20,32,354/- (Rs. 18,47,093/- from salary and allowances, Rs.97,661/- from EL encashment, Rs. 66,000/- from house rent and Rs. 21,600/- from IFCI bond maturity) and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, Insurances, RD, SIP, Mutual Fund, Ioan-repayment, SSY, and FD is Rs.17,48,071/- (including enhancement of Rs.69,568/- in his saving bank A/cs against the balance of the previous year). Thus a sum of Rs. 2,84,283/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17.
- 2. In the financial year 2017-18, his gross income from salary and other sources is Rs. 16,73,505/- (Rs. 16,07,505/- from salary and allowances and Rs. 66,000/- from house rent) and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, Insurances, RD, SIP, Mutual Fund and loan-repayment is Rs.12,69,900/-. Thus a sum of Rs. 4,03,605/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18. The balance of Rs.1,95,595/- has decreased from his saving bank A/cs against the balance of the previous year.

In this connection it is submitted that Sri Kant has already submitted his property statements upto the financial year 2015-16 which has already been approved by Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Budaun in the online mode (application id no. 415).

The movable and immovable property statement for the financial years 2016-17 and 2017-18 have been submitted by the Officer vide his online case id no. 667 dated 07.02.2020 which was due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2016-17 and 2017-18 of Sri Ravi Kant, Addl. District and Sessions Judge, Budaun be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders?
