May kindly see the property statement submitted online dated 08.02.2020 received from Sri Rajeshwar Shukla, Special Judge, Anti Corruption V.B.UPSEB, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, income from salary, arrears & other allowances (of both the financial years) are Rs.48,56,403/-, received amount as maturity of policies are Rs.1,76,387/- and income from agriculture is Rs.3,10,000/-. Thus, the total income is Rs. 53,42,790/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, LIC, Tution fees, PPF a/c and the balance of his savings bank account(s) is also enhanced for Rs.24,29,044/- this financial year from previous year's balance, total of which is Rs.39,01,878/-. Thus, a sum of Rs.14,40,912/- was therefore available with him to meet out the household expenditure of his family consisting of three members for both the financial years 2018-19 & 2019-20.

In this connection it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Varanasi in the mlsc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements

of the financial year 2018-19 & 2019-20 firstly vide online dated 08.02.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Rajeshwar Shukla, Special Judge, Anti Corruption V.B.UPSEB, Varanasi be laid before Hon'ble Mr. Justice Pritinker Diwaker, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
