May kindly see the property statement submitted online dated 11.02.2020 received from Sri Vimal Verma, Additional Chief Judicial Magistrate, Kushinagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, income from salary (with allowances) is Rs.28,32,133/- and total deductions/ repayment/ savings/ investment (for both the financial years) against u/s 80G, GIS, CPF, Income Tax, LIC policies, PLI, PPF a/c, Sukanya Samriddhi a/c, SIP and the balance of his savings bank account(s) is enhanced for Rs.5,75,980/- this financial year from previous year's balance, total of which is Rs.15,38,878/-. Thus, a sum of Rs.12,93,255/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that Sri Vimal Verma has already submitted his property statement upto the financial year 2012-13 which had already been seen by Hon'ble Mr. Justice D.K.Arora, the then Administrative Judge, Mathura in the misc. file of the officer and of the financial year 2013-14 to 2016-17 has been submitted before Hon'ble Mr. Justice Manoj MIsra, Administrative Judge, Kushinagar for kind perusal and orders on the detailed office note, in the mIsc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements

of the financial years 2017-18 & 2018-19 vide online dated 11.02.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Vimal Verma, Additional Chief Judicial Magistrate, Kushinagar be laid before Hon'ble Mr. Justice Manoj MIsra, Administrative Judge, Kushinagar Judgeship for His Lordship's kind perusal and orders?
