May kindly see the property statement submitted online dated 19.02.2020 received from Smt. Lovely Jaiswal, Civil Judge (Sr. Div.), Mirzapur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

**(1)** In the financial year 2017-18 & 2018-19, income from salary is Rs.28,83,766/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, NPS. Loan, PPF a/cs, LIC policy and the balance of her savings bank account(s) is enhanced for Rs.6,52,311/- this financial year from previous year's balance, total of which is Rs.22,06,169/-. Thus, a sum of Rs.6,77,597/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is Chief Judicial Magistrate, Mirzapur having annual income of Rs.12,16,922/- and Rs.16,83,011/- in the financial year 2017-18 & 2018-19 respectively. In this connection, it is submitted that Smt. Lovely Jaiswal has already submitted her property statement upto the financial year 2016-17 which had already been seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Mathura in the misc. file of the officer .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 19.02.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Smt. Lovely Jaiswal, Civil Judge (Sr. Div.), Mirzapur be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker,
