May kindly see the property statement submitted online dated 14.02.2020 received from Sri Shiv Kumar Tiwari, Additional District & Sessions Judge/F.T.C., Kannauj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2013-14 & 2014-15 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-14 & 2014-15 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2013-14 & 2014-15, income from salary is Rs.16,87,158/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, Income Tax, PPF, Car loan and the balance of his savings bank account(s) is enhanced for Rs.66,309/- this financial year from previous year's balance, total of which is Rs.6,94,962/-. Thus, a sum of Rs.9,92,196/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

In this connection, it is submitted that Sri Shiv Kumar Tiwari has already submitted his property statement at the time of entering into judicial service which had already been seen by Hon'ble Mr. Justice Shri Kant Tripathi, the then Administrative Judge, Unnao in the misc. file of the officer and of the financial year 2009-10 & 2010-11 and 2011-12 & 2012-13 are currently processed online & separate notes has been made on case-id no.708 and 709 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2013-14 & 2014-15 in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-14 & 2014-15 vide online dated 14.02.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that he is seeking deep

apology for delay submission of aforesaid statements and assure that in future he will send the statements in time & would always be grateful to the Hon'ble Court in his attached letter dated 13.02.2020.

May, therefore, if approved, property statements of the financial year 2013-14 & 2014-15 of Sri Shiv Kumar Tiwari, Additional District & Sessions Judge/F.T.C., Kannauj be laid before Hon'ble Mr. Justice V.K.Birla, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
