May kindly see the property statement submitted online dated 13.02.2020 received from Smt. Kamlesh Kuchhal, Special Judge (SC/ST, Pev. Of Atroci Act), Moradabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2016-17 & 2017-18, Total income is Rs.38,79,132/- (including income from salary & allowances are Rs.35,32,180/- and interest on FDR, NSC, PPF & SB a/c are Rs.3,46,952/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, PPF a/cs, LIC policies, FDR and the balance of her savings bank account(s) is enhanced for Rs.4,37,353/- this financial year from previous year's balance, total of which is Rs.29,94,999/-. Thus, a sum of Rs.8,84,133/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband's income of Rs.3,34,898/- & Rs.4,30,200/- for the assessment year 2017-18 & 2018-19 respectively.

In this connection, it is submitted that Smt. Kamlesh Kuchhal has already submitted her property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Vipin Sinha, the then Administrative Judge, Moradabad in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 13.02.2020. As such, there is delay in submitting the same from the part of the officer for which she has apologized for late submission of the aforesaid statements in her attached letter dated 13.02.2020.

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 of Smt. Kamlesh Kuchhal, Special Judge (SC/ST, Pev. Of Atroci Act), Moradabad be laid before Hon'ble Mr. Justice Pritinker Diwaker, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
