May kindly see the property statement submitted online dated 25.02.2020 received from Sri Sudhir Kumar-V, Presiding Officer, Shahjahanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, total income is Rs.35,00,790/- (income from salary is Rs.30,40,790/-, income from farming is Rs.3,10,000/- & cash in hand is Rs.1,50,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, Insurance policies, PPF a/cs, SIP, PLI and the balance of his savings bank account(s) is enhanced for Rs.2,96,027/- this financial year from previous year's balance, total of which is Rs.21,55,987/-. Thus, a sum of Rs.13,44,803/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that Sri Sudhir Kumar-V has already submitted his property statement upto the financial year 2015-16, which had already been seen by Hon'ble Mr. Justice Shri Narayan Shukla, the then Administrative Judge, Lucknow in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 25.02.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Sri Sudhir Kumar-V, Presiding Officer, Shahjahanpur be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Shahjahanpur Judgeship for His Lordship's kind perusal and orders?
