May kindly see the property statement submitted online dated 17.02.2020 received from Sri Abhishek Tripathi, Civil Judge (Sr. Div.), Sant Kabir Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 (i.e., from 16.01.2017 to 31.03.2017) & 2017-18, income from salary is Rs.8,98,232/-(including interest income of Rs.1,028/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, LIC, Income Tax, deductions under section 80C and the balance of his savings bank account(s) is enhanced for Rs.2,474/- this financial year from previous year's balance, total of which is Rs.1,48,571/-. Thus, a sum of Rs.7,49,661/- was therefore available with him to meet out the household expenditure of himself in the financial years 2016-17 (about 2.5 months) & 2017-18.

In this connection, it is submitted that the officer has already submitted his property statements at the time of entering into judicial service which is currently processed online & a separate note has been made on case-id no.726.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 17.02.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that the undersigned is a new recruit in the service and working his first place of posting i.e.,

Sant Kabir Nagar after completion of Induction Training Programme at I.J.T.R, he seeks unconditional apology & promise for future to be more aware & cautious in sending his property statements within time. He has also requested to accept the same considering his short tenure of service & lesser experience, in his letter dated 12.03.2020 attached with the statements.

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Sri Abhishek Tripathi, Civil Judge (Sr. Div.), Sant Kabir Nagar be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
