

**Registrar(J)(Budget)**

May kindly see the property statement submitted online dated 18.02.2020 received from Sri Amit Kumar Prajapati, Additional District & Sessions Judge, Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2012-13 & 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-13 & 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2012-13 & 2013-14, total income is Rs.26,23,571/- (income from salary is Rs.19,82,792/-, amount withdrawal from LIC is Rs.2,02,942/-, amount on STDR closed is Rs.3,39,068/- & Transfer allowance is Rs.98,769/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Processing fee loan, loan, LIC, PPF a/c, NSC and investment in Rohtas project limited are Rs.19,32,386/-. Thus, a sum of Rs.6,91,185/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.1,08,190/- this financial year from previous year's balance.

It is pertinent to mention here that his wife as an Advocate earns Rs.12,000/- per month.

In this connection, it is submitted that Sri Amit Kumar Prajapati has already submitted his property statement upto the financial years 2011-12 which had already been seen by Hon'ble Mr. Justice A.N.Mittal, the then Administrative Judge, Sonbhadra in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2012-13 & 2013-14 in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial years 2012-13 & 2013-14 vide

online dated 18.02.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2012-13 & 2013-14 of Sri Amit Kumar Prajapati, Additional District & Sessions Judge, Sultanpur be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
