May kindly see the property statement submitted online dated 18.02.2020 received from Sri Amit Kumar Prajapati, Additional District & Sessions Judge, Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, income from salary is Rs.27,22,629/- and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, NPS, Income Tax, LIC, PPF a/c, NSC, investments in Rohtas Projects Limited and the balance of his savings bank account(s) is enhanced for Rs.7,62,951/- this financial year from previous year's balance, total of which is Rs.21,50,445/-. Thus, a sum of Rs.5,72,184/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife as an Advocate earns Rs.16,000/- per month.

In this connection, it is submitted that Sri Amit Kumar Prajapati has already submitted his property statement upto the financial years 2011-12 which had already been seen by Hon'ble Mr. Justice A.N.Mittal, the then Administrative Judge, Sonbhadra in the misc. file of the officer and of the financial years 2012-13 & 2013-14 and 2014-15 & 2015-16 are currently processed online & separate notes has been made on case-id no.733 and 734 respectively..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 18.02.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Sri Amit Kumar Prajapati, Additional District & Sessions Judge, Sultanpur be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
