May kindly see the property statement submitted online dated 19.02.2020 received from Sri Sanjeev Shukla, Additional District & Sessions Judge, Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, income from salary is Rs.34,52,966/- (including Rs.13,718/- as income from interests) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, LIC policies, PPF, Shares and the balance of his savings bank account(s) is enhanced for Rs.1,20,393/- this financial year from previous year's balance, total of which is Rs.13,81,034/-. Thus, a sum of Rs.20,71,932/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that Sri Sanjeev Shukla has already submitted his property statement upto the financial year 2013-14, which had already been seen by Hon'ble Mr. Justice Virendra Kumar-II, the then Administrative Judge, Pilibhit in the misc. file of the officer with the direction issued to the officer should be more cautious in future for submitting property statements according to circulars of this Court and of the financial years 2014-15 & 2015-16 are currently processed online & a separate note has been made on case-id no.730.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements

of the financial years 2016-17 & 2017-18 vide online dated 19.02.2020. As such, there is delay in submitting the same from the part of the officer

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Sri Sanjeev Shukla, Additional District & Sessions Judge, Pilibhit be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
