May kindly see the online application no. 743 dated 19.02.2020 by which Smt. Kalpana –II, Addl. District and Sessions Judge/FTC, Auraiya has submitted her movable and immovable property statement for the financial years 2012-13 and 2013-14.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial year 2012-13 and 2013-14 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial years 2012-13 and 2013-14, her gross income from salary is Rs. 17,24,589/- and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF, LIC and NSC is Rs.13,99,550/- (including enhancement of Rs.8,06,436/- in her saving bank A/cs against the balance of the previous year). Thus a sum of Rs. 3,25,039/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial years 2012- 13 and 2013-14.

It is pertinent to mention that the husband of the officer, Dr. Brijesh Singh is a lecturer in U.P. Govt. whose annual income is Rs. 5,00,000/-.

In this connection it is submitted that the Officer has already submitted her property statements upto the financial year 2009-10 which has already been seen by Hon'ble Mr. Justice Shishir Kumar, the then Administrative Judge, Firozabad in the miscellaneous file of the Officer.

For the preceding financial year, she has submitted her property statement for the financial years 2010-11 and 2011-12, which has been processed presently online and separate office note has already been submitted for orders on separate case id no 742.

The movable and immovable property statements for the financial years 2012-13 and 2013-14 have been submitted by the Officer vide her online case id no. 743 dated 19.02.2020 which was due to be submitted upto the end of the financial year 2014-15. As such, there is delay in submitting the property statements from the part of the officer.
