May kindly see the property statement submitted online dated 20.02.2020 received from Sri Adarsh Srivastava, Additional Chief Judicial Magistrate (N.R.), Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2015-16 & 2016-17, income from salary is Rs.15,22,892/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, PPF, Car loan, Cash purchase against Car and the balance of his savings bank account(s) is enhanced for Rs.1,44,579/- this financial year from previous year's balance, total of which is Rs.7,36,800/-. Thus, a sum of Rs.7,86,092/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that his wife is Judicial Officer having annual income of Rs.6,89,216/- in the financial year 2016-17.

In this connection, it is submitted that Sri Adarsh Srivastava has already submitted his property statement at the time of entering into judicial service which had already been seen by Hon'ble Mr. Justice Mahendra Dayal, the then Administrative Judge, Hardoi in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 vide online dated

20.02.2020. As such, there is delay in submitting the same from the

part of the officer.
