In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2015-16 & 2016-17, income from salary is Rs.15,22,892/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, PPF, Car loan, Cash purchase against Car and the balance of his savings bank account(s) is enhanced for Rs.1,44,579/- this financial year from previous year's balance, total of which is Rs.7,36,800/-. Thus, a sum of Rs.7,86,092/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that his wife is Judicial Officer having annual income of Rs.6,89,216/- in the financial year 2016-17.
