May kindly see the property statement submitted online dated 20.02.2020 received from Sri Adarsh Srivastava, Additional Chief Judicial Magistrate (N.R.), Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, income from salary is Rs.19,21,254/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, PPF, Car loan, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.3,38,432/- this financial year from previous year's balance, total of which is Rs.10,01,794/-. Thus, a sum of Rs.9,19,460/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that his wife is Judicial Officer having annual income of Rs.9,29,210/- & Rs.12,41,497/- in the financial year 2017-18 & 2018-19 respectively.

In this connection, it is submitted that Sri Adarsh Srivastava has already submitted his property statement at the time of entering into judicial service which had already been seen by Hon'ble Mr. Justice Mahendra Dayal, the then Administrative Judge, Hardoi in the misc. file of the officer and of the financial year 2015-16 & 2016-17 are currently processed online & separate notes has been made on statement-id no.744.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years

2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 20.02.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Adarsh Srivastava, Additional Chief Judicial Magistrate (N.R.), Varanasi be laid before Hon'ble Mr. Justice Abhinava Upadhyaya, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
