

**Registrar (J)(Budget)**

May kindly see the online letter 19.02.20 received from Smt. Suneeta Sharma, Civil Judge (Sr. Div.), Hamirpur regarding submission of statements of movable and immovable properties for the financial years 2017-18 and 2018-19 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 and 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial year 2017-18, her gross income from salary is Rs. 11,80,557/- and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF, insurances and loan-repayment is Rs.8,71,288/- (including enhancement of balance of Rs. 2,26,755/- in her saving bank A/c against the balance of the previous year). Thus a sum of Rs. 3,09,269/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2017-18.
2. In the financial year 2018-19, her gross income from salary is Rs. 16,83,185/- and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF, Insurances, Loan- repayment, Sukanya Samridhi Yojna and Mutual Fund is Rs. 13,53,476/- . Thus a sum of Rs. 3,29,709/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2018-19. The balance of Rs. 3,23,066/- has decreased from her saving bank A/c balance against the balance of the previous year.

It is pertinent to mention that the husband of the officer, Sri Amit Kumar, is an Income Tax Inspector whose annual income are Rs. 8.50 Lacs in 2017-18 and Rs. 9.60 Lacs in 2018-19.

In this connection it is submitted that the Officer has already submitted her property statements upto the financial year 2016-17 which has already been seen by Hon'ble Mr. Justice Mahendra Dayal, the then Administrative Judge, Hardoi in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial years 2017-18 and 2018-19 have been submitted by the Officer vide her online case id no. 749 dated 19.02.2020 which was due to be submitted upto the end of the financial year 2019-20. As such, there is no delay in submitting the property statements from the part of the officer.
