In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-15 and 2015-16 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial years 2014-15 and 2015-16, her gross income from salary is Rs. 21,17,868/- and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF and LIC is Rs.7,35,798/-. Thus a sum of Rs. 13,82,070/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial years 2014-15 and 2015-16. The balance of Rs. 13,399/- has decreased from her saving bank A/cs against the balance of the previous year.

It is pertinent to mention that the husband of the officer, Dr. Brijesh Singh is a lecturer in U.P. Govt. whose annual income is Rs. 7, 21,079/-.

In this connection it is submitted that the Officer has already submitted her property statements upto the financial year 2009-10 which has already been seen by Hon'ble Mr. Justice Shishir Kumar, the then Administrative Judge, Firozabad in the miscellaneous file of the Officer.

For the preceding financial year, she has submitted her property statement for the financial years 2010-11 & 2011-12 and 2012-13 & 2013-14 which have been processed presently online and separate office notes have already been submitted for orders on separate case id nos 742 and 743.

The movable and immovable property statements for the financial years 2014-15 and 2015-16 have been submitted by the Officer vide her online case id no. 751 dated 19.02.2020 which was due to be submitted upto the end of the financial year 2016-17. As such, there is delay in submitting the property statements from the part of the officer.
