May kindly see the online application no. 752 dated 19.02.2020 by which Smt. Kalpana –II, Addl. District and Sessions Judge/FTC, Auraiya has submitted her movable and immovable property statement for the financial years 2016-17 and 2017-18.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial years 2016-17 and 2017-18, her gross income from salary is Rs. 23,52,431/- and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF, loan-repayment and LIC is Rs.10,02,036/-. Thus a sum of Rs.13,50,395/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial years 2016- 17 and 2017-18. The balance of Rs. 1,67,850/- has decreased from her saving bank A/cs against the balance of the previous year.

It is pertinent to mention that the husband of the officer, Dr. Brijesh Singh is an assistant professor in U.P. Govt. whose annual income is Rs. 8,00,000/-.

In this connection it is submitted that the Officer has already submitted her property statements upto the financial year 2009-10 which has already been seen by Hon'ble Mr. Justice Shishir Kumar, the then Administrative Judge, Firozabad in the miscellaneous file of the Officer.

For the preceding financial years, officer has submitted her property statement for the financial years 2010-11 & 2011-12, 2012-13 & 2013-14 and 2014-15 & 2015-16 which have been processed presently online and separate office notes have already been submitted for orders on separate case id nos 742, 743 and 751.

The movable and immovable property statements for the financial years 2016-17 and 2017-18 have been submitted by the Officer vide her online case id no. 752 dated 19.02.2020 which was due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the statements of movable and immovable property for the financial years 2016-17 and 2017-18 Smt. Kalpana –II, Addl. District and Sessions Judge/FTC, Auraiya kindly be laid before Hon'ble Ms. Justice Naheed Ara Moonis, Administrative Judge, Auraiya Judgeship for Her Lordship's kind perusal and orders?
