May kindly see the online application by which Smt. Kalpana-II, Addl. District and Sessions Judge/FTC, Auraiya has submitted her movable and immovable property statement for the financial years 2018-19 and 2019-20.

In the aforesaid property statements, it was found that no moneys were left with her in the financial years 2018-19 and 2019-20. So an objection was raised dated 17.09.2020 to ask the officer to clarify how she had managed to maintain expenditure of his family in the financial years 2018-19 and 2019-20. In reply to this objection, the officer has submitted her clarification on dated 19.10.2020. The clarification submitted by the officer is being reproduced in verbatim:-

For the above mentioned objection ,I humbly submit that my husband is a Doctor, Govt.employee(Associate professoer in Saifai Medical collage Etawah).So ,we together try to manage and maintain the household expenditures of our faimly

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

- 1. In the financial year 2018-19, her gross income from salary is Rs. 19,70,089/- and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF, Ioan-repayment and LIC is Rs.23,16,537/- (including enhancement of balance of Rs.13,49,582/- in her saving bank A.cs against the balance of the previous year). Thus no money was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2018-19.
- 2. In the financial year 2019-20, her gross income from salary and other sources is Rs. 23,38,367/- (Rs.22,40,367/- from salary and Rs.98,000/- from NSC maturity) and total

deductions/Savings/investments against CPF, GIS, Income Tax, PPF, Ioan-repayment and LIC is Rs.28,81,091/- (including enhancement of balance of Rs.18,07,705/- in her saving bank A.cs against the balance of the previous year). Thus no money was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2019-20.

It is pertinent to mention that the husband of the officer, Dr. Brijesh Singh, is Associate Professor in Medical College (U.P. Govt), Etawah whose annual income is Rs. 18,50,000/-.

In this connection it is submitted that the Officer has already submitted her property statements upto the financial year 2017-18 which has already been seen by Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Auraiya in online mode vide application id no. 752.

The movable and immovable property statements for the financial years 2018-19 and 2019-20 have been submitted by the Officer vide her online case id no. 755 dated 05.08.2020 which is due to be submitted upto the end of the financial year 2020-21. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the statements of movable and immovable property for the financial years 2018-19 and 2019-20 of Smt. Kalpana-II, Addl. District and Sessions Judge/FTC, Auraiya kindly be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders?
