May kindly see the online application no. 763 dated 22.02.2020 by which Sri Lalta Prasad-II, Addl. District and Sessions Judge, Azamgarh has submitted his movable and immovable property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-15 and 2015-16 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial years 2014-15 and 2015-16, his gross income from salary and other sources is Rs. 36,12,642/- (Rs. 35,97,173/- from salary, Rs. 5,000/- from Agriculture and Rs. 10,469/- from interest) and total deductions/Savings /investments against GPF, GIS, Income Tax, PPF and LIC is Rs.10,40,050/-. Thus a sum of Rs.25,72,592/- was therefore available with him to meet out the household expenditure of his family consisting of seven members in the financial years 2014-15 and 2015-16. The balance of Rs. 46,402/- has decreased from his saving bank A/cs against the balance of the previous year.

It is pertinent to mention that the agricultural income of, the wife of the officer, Smt. Saroj Rani was Rs. 1,15,000/- in the financial years 2014-15 and 2015-16.

In this connection it is submitted that the Officer has already submitted his property statements upto the financial year 2009-10 which has already been seen by Hon'ble Mr. Justice Vimlesh Kumar Shukla, the then Administrative Judge, Sant Kabir Nagar in the miscellaneous file of the Officer.

For the preceding financial years, officer has submitted her property statement for the financial years 2010-11 & 2011-12 and 2012-13 & 2013-14 which have been processed presently online and separate office notes have already been submitted for orders on separate case id no 761 and 762.

The movable and immovable property statements for the financial years 2014-15 and 2015-16 have been submitted by the Officer vide his online case id no. 763 dated 22.02.2020 which was due to be submitted upto the

end of the financial year 2016-17. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16 of Sri Lalita Prasad-II, Addl. District and Sessions Judge, Azamgarh kindly be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Azamgarh Judgeship for His Lordship's kind perusal and orders?
