May kindly see the online letter 21.02.2020 received from Sri Ashish Jain, Addl. District and Sessions Judge, Hathras regarding submission of statements of movable and immovable properties for the financial years 2017-18 and 2018-19 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 and 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2017-18, his gross income from salary and other sources is Rs. 20,55,548/- (Rs. 19,63,590/- from salary and Rs. 91,958/- from saving bank interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, SSY, RD and Insurances is Rs. 8,79,316/-. Thus a sum of Rs. 11,76,232/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18. The balance of Rs. 25,711/- has decreased from his saving bank A/cs against the balance of the previous year.
2. In the financial year 2018-19, his gross income from salary and other sources is Rs. 31,46,654/- (Rs. 29,24,332/- from salary, Rs. 1,25,000/- from RD maturity and Rs. 97,322/- from S.B. interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, SSY, RD, Insurances and Loan-repayment is Rs.12,19,107/-. Thus a sum of Rs. 19,27,547/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19. The balance of Rs. 6,45,139/- has decreased from his saving bank A/cs against the balance of the previous year.

It is pertinent to mention that Smt. Sweta Jain, wife of the officer, has the income from tuition of Rs.3,80,000/- in the financial year 2017-18 and Rs. 3,85,000/- in the financial year 2018-19.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2016-17 which has already been seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Hathras in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2017-18 and 2018-19 have been submitted by the Officer vide his online case id no. 771 dated 21.02.2020 which was due to be submitted upto the end of the

financial year 2019-20. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2017-18 and 2018-19 of Sri Ashish Jain, Addl. District and Sessions Judge, Hathras be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi. Administrative Judge, Hathras Judgeship for His Lordship's kind perusal and orders?
