May kindly see the property statement submitted online dated 28.02.2020 received from Smt. Alka Bharti, Additional District & Sessions Judge/F.T.C., Pilibhit regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2016-17 & 2017-18, income from salary is Rs.24,23,258/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, CPF, Mutual funds, PPF a/c and Life Insurance plan are Rs.19,11,414/- and the balance of her savings bank account(s) is also reduced for Rs.1,94,581/- this financial year from previous year's balance. Thus, a sum of Rs.7,06,425/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is Additional District & Sessions Judge/F.T.C., Pilibhit having annual income of Rs.12,40,557/- & Rs.12,59,389/- in the financial years 2016-17 & 2017-18 respectively.

In this connection, it is submitted that Smt. Alka Bharti has already submitted her property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Abhai Kumar, the then Administrative Judge, Jalaun at Orai in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property

statements for the financial years 2016-17 & 2017-18 vide online dated 28.02.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Smt. Alka Bharti, Additional District & Sessions Judge/F.T.C., Pilibhit be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
