May kindly see the online letter 03.03.2020 received from Sri Raghvendra Mani, Civil Judge (Sr. Div.), Amroha regarding submission of statements of movable and immovable properties for the financial years 2015-16 and 2016-17 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-16 and 2016-17 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

- In the financial year 2015-16, his gross income from salary and other sources is Rs. 10,55,753/- (Rs. 10,52,794/- from salary and 2,959/from S.B. interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Loan- repayment, LIC is Rs. 3,25,394/-. Thus a sum of Rs. 7,30,359/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2015-16. The balance of Rs. 56,132/has decreased from his saving bank A/c against the balance of the previous year.
- 2. In the financial year 2016-17, his gross income from salary and other sources is Rs. 7,03,094/- (Rs. 6,99,383/- from salary and Rs. 3,711/- from S.B. interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, LIC, and Loan-repayment is Rs. 2,98,183/- (including enhancement of balance of Rs. 27,979/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 4,04,911/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2016-17.

In this connection it is submitted that the officer has already submitted his property statements held at the time of entering Judicial Services has already been seen by Hon'ble Mr. Justice Rajiv Sharma, the then Administrative Judge, Ambedkar Nagar in the in the Misc. file of the officer.

For the preceding financial years, officer has submitted his property statements for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 which have been processed presently online and separate office notes have already been submitted for orders on separate case id no 821, 823 and 824.

The movable and immovable property statement for the financial years 2015-16 and 2016-17 have been submitted by the Officer vide his online case id no. 825 dated 03.03.2020 which was due to be submitted upto the end of the financial year 2017-18. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2015-16 and 2016-17 of Sri Raghvendra Mani, Civil Judge (Sr. Div.), Amroha be laid before Hon'ble Mr. Justice Devendra Kumar Upadhyaya, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders?
