May kindly see the online 03.03.2020 received from Sri Jasveer Singh Yadav, Addl. Civil Judge (Sr. Div.), Bareilly regarding submission of statements of movable and immovable properties for the financial years 2017-18 and 2018-19 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 and 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2017-18, his gross income from salary is Rs. 9,04,431/- and total deductions/Savings/investments against CPF, GIS, income tax, PPF, Insurance, and loan-repayment is Rs. 5,49,254/- (including enhancement of balance of Rs.25,563/- in his saving bank A.cs against the balance of the previous year). Thus a sum of Rs.3,55,177/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2017-18.
2. In the financial year 2018-19, his gross income from salary is Rs. 13,30,501/- and total deductions/Savings/investments against CPF, GIS, income tax, PPF, Insurances, and loan-repayment is Rs.6,99,249/- (including enhancement of balance of Rs. 1,47,103/- in his saving bank A.cs against the balance of the previous year.) Thus a sum of Rs. 6,31,252/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2018-19.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2016-17 which has already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Fatehpur in the in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2017-18 and 2018-19 have been submitted by the Officer vide his online case id

no. 835 dated 03.03.2020 which was due to be submitted upto the end of the financial year 2019-20. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2017-18 and 2018-19 of Sri Jasveer Singh Yadav, Addl. Civil Judge (Sr. Div.), Bareilly be laid before Hon'ble Mr. Justice Alok Singh, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
