

**Registrar (J)(Budget)**

May kindly see the online letter 06.03.2020 received from Sri Siddharth Singh, Addl. District and Sessions Judge, Raebareli regarding submission of statements of movable and immovable properties for the financial years 2016-17 and 2017-18 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2016-17, his gross income from salary and other sources is Rs. 17,40,842/- (Rs. 13,35,065/- from salary, Rs. 1,16,855/- from NSC, Rs. 2,21,133/- from Mutual fund and Rs. 67,789/- from ICICI policy maturity) and total deductions/Savings/investments against NPS, GIS, Income Tax, GVR, PPF, Car loan-repayment, Insurances, Mutual Fund, and Gold Bond is Rs. 6,51,944/-. Thus a sum of Rs. 10,88,898/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17. The balance of Rs. 1,44,167/- has decreased from his saving bank A/cs against the balance of the previous year.
2. In the financial year 2017-18, his gross income from salary and other sources is Rs. 27,61,843/- (Rs. 13,15,018/- from salary, Rs. 35,000/- from NSC and Rs. 14,11,825/- from FD maturity) and total deductions/Savings/investments against NPS, GIS, Income Tax, GVR, PPF, Car loan-repayment, Mutual Fund and insurances is Rs. 18,38,410/- (including enhancement of balance of Rs. 4,13,660/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 9,23,433/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.

It is pertinent to mention that Smt. Archana Singh, the wife of the officer, is a Librarian in Dharam Degree College, Unnao whose annual incomes are Rs. 3,67,712/- in the F.Y. 2016-17 and Rs. 3,81,643/- in the F.Y. 2017-18.

In this connection it is submitted that the officer has already submitted his property statements held upto the financial year 2013-14 which has already been seen by Hon'ble Mr. Justice Vipin Sinha, the then Administrative Judge, Kushinagar in the in the Misc. file of the officer.

For the preceding financial years, the officer has submitted his property statements for the financial years 2014-15 and 2015-16 which have been

processed presently online and separate office note has already been submitted for orders on separate case id no 848.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 have been submitted by the Officer vide his online case id no. 847 dated 06.03.2020 which was due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2016-17 and 2017-18 of Sri Siddharth Singh, Addl. District and Sessions Judge, Raebareli be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Raebareli Judgeship for His Lordship's kind perusal and orders?
