May kindly see the property statement submitted online dated 18.03.2020 received from Sri Devendra Nath Goswami, Additional Chief Judicial Magistrate (Railway), Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, income from salary is Rs.28,18,388/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, PPF, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.3,47,875/- this financial year from previous year's balance, total of which is Rs.11,59,015/-. Thus, a sum of Rs.16,59,373/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that his wife earns Rs.4,80,000/- annual from teaching.

In this connection, it is submitted that Sri Devendra Nath Goswami has already submitted his property statement of the financial year 2014-15 which had already been seen by Hon'ble Mr. Justice D.K.Arora, the then Administrative Judge, Gonda in the misc. file of the officer and of the financial years 2015-16 & 2016-17 has been submitted before Hon'ble Mr. Justice Arvind Kumar Mishra-I, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders (in the misc. file of the officer).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements

of the financial years 2017-18 & 2018-19 vide online dated 18.03.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Devendra Nath Goswami, Additional Chief Judicial Magistrate (Railway), Jhansi be laid before Hon'ble Mr. Justice Arvind Kumar Mishra-I, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders?
