

### Joint Registrar, Admin-1

May kindly see the online letter **21.09.2019** received from Sri Hemant Kumar Kushwaha, Addl. Civil Judge (Sr. Div.)/ACJM, Meerut regarding submission of statements of movable and immovable properties for the financial year **2018-19** proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years **2018-19** of the Officer concerned, details of income, deductions, savings, investment and expenditure made by **him** are given below.

1. In the financial year **2018-19**, **his** gross income from salary and other sources is Rs.17,67,040/- (income from Salary is Rs.16,90,540/- and from NSC maturity Rs.76,500/-) and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF and LIC is Rs.14,01,542/-(including enhancement of Rs.9,38,295/- in his saving bank a/cs against the balance of previous year). Thus a sum of Rs.3,65,498/- was therefore available with him to meet out the household expenditure of his family consisting of **five** members in the financial year **2018-19**.

In this connection it is submitted that Sri Kushwaha has already submitted his property statements held at the time of entering Judicial Services which have already been seen by Hon'ble Mr. Justice Sabhajeet Yadav, the then Administrative Judge, Azamgarh in the miscellaneous file of the Officer. For the preceding financial years, he has submitted his property statements upto the financial years 2009-10, 2010-11 and 2011-12, 2012-13, 2013-14, 2014-15, 2015-16, 2016-17 and 2017-18 out of which property statements for the F.Y. 2009-10, 2010-11, 2012-13, 2014-15, 2015-16, 2016-17 and 2017-18 have been processed online and separate office notes have already been submitted for order on separate **case id no. 42, 44, 81, 83, 84, 85 and 87 respectively.**

The movable and immovable property statements for the financial year 2018-19 has been submitted by the Officer vide his online case id no. 87 dated 21.09.2019 which was due to be submitted upto the end of the financial year 2019-20 as per two year block policy. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial year 2018-19 of Sri Hemant Kumar Kushwaha, Addl. Civil Judge (Sr. Div.)/ACJM, Meerut be laid before Hon'ble Mr. Justice Manoj Misra, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
