May kindly see the online 23.04.2020 received from Sri Krishna Chandra Pandey, Special Judge (E.C. Act), Saharanpur regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2018-19, his gross income from salary and other sources is Rs. 35,66,040/- ( Rs. 33,13,551/- from salary and arrears, Rs. 60,000/- from agriculture, Rs. 60,849/- from bank interest, Rs. 30,000/- from LIC money back, Rs. 1,640/- from REC and Rs. 1,00,000/- from rental income) and total deductions /Savings/investments against GPF, GIS, Income Tax , Insurance, loan-repayment and PPF is Rs. 25,42,511/- (including enhancement of Rs. 9,32,583/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs.10,23,529/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2018-19.
2. In the financial year 2019-20, his gross income from salary and other sources is Rs. 26,56,587/- (Rs.23,88,365/- from salary, Rs. 50,000/- from agriculture, Rs. 71,606/- from bank interest, Rs. 24,976/- from LIC money back, Rs. 21,640/- from REC and Rs. 1,00,000/- from rental income)) and total deductions /Savings/investments against GPF, GIS, Income Tax , Insurance, loan-repayment and PPF is Rs. 14,82,164/-. Thus a sum of Rs.11,74,423/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2019-20. The balance of Rs. 2,88,526/- has decreased from his saving bank A/c against the balance of the previous year.

In this connection it is submitted that the officer has already submitted his property statements up to the financial year 2017-18 which has already been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Saharanpur in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2018-19 and 2019-20 have been submitted by the Officer vide his online application dated 23.04.2020 which is due to be submitted up to the end of

the financial year 2020-21. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2018-19 and 2019-20 of Sri Krishna Chandra Pandey, Special Judge (E.C. Act), Saharanpur be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
