

**Registrar(J)(Budget)**

May kindly see the property statement submitted online dated 08.05.2020 received from Sri Mahendra Singh-IV, Additional District & Sessions Judge, Jaunpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2010-11 & 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2010-11 & 2011-12 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2010-11 & 2011-12, total income is Rs.25,87,471/- (income from salary is Rs.24,61,026/-, LIC refund of Rs.1,20,445/- and dress allowance of Rs.6,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, Income Tax, Home loan, Insurance policies, Tax saving bond and the balance of his savings bank account(s) is enhanced for Rs.28,520/- this financial year from previous year's (i.e., the balance of 31.12.2009, as mentioned in the statement of the financial year 2009-10 in the misc. file of the officer concerned) balance, total of which is Rs.15,86,468/-. Thus, a sum of Rs.10,01,003/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Arun Tandon, the then Administrative Judge, Lucknow in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2010-11 & 2011-12 in its next financial year i.e., 2012-13 upto March 2013. He has submitted movable and immovable property statements of the financial years 2010-11 & 2011-12 vide online dated

08.05.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2010-11 & 2011-12 of Sri Mahendra Singh-IV, Additional District & Sessions Judge, Jaunpur be laid before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
