

### **Joint Registrar (J)(Budget)**

May kindly see the online office note dated 16.10.2020 regarding submission of statement of movable and immovable properties for the financial years 2010-11 and 2011-12 of Sri Mahendra Singh-IV, the then Additional District Judge presently Special Judge(E.C.Act), Jaunpur which was submitted before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Jaunpur Judgeship for kind perusal and orders. On the aforesaid office note His Lordship's has been pleased to order as under :

**“Officer be asked to submit explanation within a fortnight regarding delayed submission of property statement.”**

So an objection dated 05.12.2020 was raised and in reply to this objection, the officer has submitted his clarification which is placed below in verbatim :

“Kindly have the reference of the objections raised in respect of property statements submitted by me in delay. These objections are communicated to me through e-services portal. In compliance of instructions the required report /explanations are given hereunder:-

1-That as per directions contained in C.L. no. 16 dated 13.05.2004, every judicial officer have to submit his statement in respect of movable immovable property at the time of entering into service and thereafter these statements are to be submitted every third year.

2- That I have submitted my statement of property in the year 2005 when entered into service and thereafter submitted up to year 2010.

3- That from the year 2006 to 2020 I have purchased two cars and two residential houses. Reports along with details and documents have already been sent to Hon'ble Court as and when any movable or immovable property is acquired.

A report was sent by me on 28.01.2006 regarding purchase of a new Santro car. The statement of property till 2009-2010 was sent on 25.08.2011. On 22.12.2018 a report regarding a purchase of a new Honda City car has been submitted by me. On 04.02.2019 an information relating to purchase of Flat no. J/7/41 Sushant Golf City at Lucknow was sent by me. On 04.02.2020 another report was submitted relating to purchase of Flat no. 1404 White Bell at Ghaziabad.

4- That it is worthwhile to mention that immovable properties where came in my possession during 2018 and 2019, while entered during 2010 and 2011 respectively. During interval of above 8-9 years money was paid on different dates/ years. That is why, the actual expenses could not be assessed during the relevant period and the statements also could not be submitted in time. Despite of above circumstances, I have submitted detailed informations about the acquiring of every movable and immovable property.

As stated above, the applicant has no deliberate intention to disobey the directions of the Hon'ble High Court. The delay in submission of property

statement is regretted indeed. I beg my unconditional apology before the Hon'ble High Court for any error whatsoever committed by me in this regard.”

May, if approved, the movable and immovable property statements for the financial years 2010-11 and 2011-12 of Sri Mahendra Singh-IV, the then Additional District Judge presently Special Judge(E.C.Act), Jaunpur be laid before Hon'ble Mr. Justice Om Prakash-VII, , Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and further orders?
